

Sony Electronics' June 2026 Alpha Wildlife Photo Sweepstakes
OFFICIAL RULES

OPEN ONLY TO ELIGIBLE LEGAL RESIDENTS OF THE 50 UNITED STATES OR DISTRICT OF COLUMBIA, 18+ YEARS OF AGE (19+ in AL, NE) AS OF TIME OF ENTRY.

1. THE SWEEPSTAKES; PROMOTION PERIOD: Sony Electronics' June 2026 Alpha Wildlife Photo Sweepstakes ("Sweepstakes") is sponsored by Sony Electronics Inc. ("Sponsor"). The Sweepstakes starts on 06/10/2026 beginning at 9:00 AM Pacific Standard Time ("PST") and ends on 06/25/2026 at 11:59 PM PST (the "Promotion Period"). All entries must be received by Sponsor during the Promotion Period.

2. HOW TO ENTER (INTERNET REQUIRED):

Online Entry Only: To enter the Sweepstakes, entrant must, during the Promotion Period, post on Instagram:

- (i) one (1) post, single image, image carousel, or video to entrant's Instagram feed either captured using a Sony camera or showcasing entrant's Sony camera, and correlating with the associated Wildlife theme. In the post description, share details of what entrant's favorite Sony camera or lens is and why;
- (ii) tag or mention @sonyalpha in the Instagram post; **and**
- (iii) include the hashtags **#SonyAlphaWildlifeContest2026** **and** **#SweepstakesEntry** (collectively, "Submission")
- (iv) bonus entry: tag your favorite retailer or the last place you bought your last Sony camera or lens in your entry post that you post on your profile

Once posted on Instagram, entrant's Submission must remain on Instagram until the end of the Promotion Period, otherwise entrant's entry will not be eligible to win. Entrant must follow Instagram's terms and conditions.

right to decide all matters and disputes arising out of or relating to the Sweepstakes and Sponsor's decisions shall be final and binding in all matters pertaining to this Sweepstakes.

There will be one (1) Grand Prize Winner. The Grand Prize Winner can choose one (1) product from the following list as the Grand Prize:

- FE 200–600 mm F5.6–6.3 G OSS Full-frame Telephoto Zoom Lens (Model: SEL200600G) [ARV \$2,099.99]; OR
